

2019-2020 Federal Direct PLUS Loan Request Form

Choosing a PLUS Lender

Beginning July 1, 2010, the only lender option for PLUS loans is the federal government, through the Federal Direct PLUS Loan Program. You may use this form to apply for the Federal Direct Plus loan. If you have borrowed a PLUS loan previously from another lender, you will have to switch to the Federal Direct PLUS Loan Program if you wish to borrow for periods of enrollment beginning on or after July 1, 2010. If you are a new PLUS loan borrower, your loan will automatically be certified through the Federal Direct PLUS Loan Program.

I authorize Wake Tech Financial Aid to transmit my Federal PLUS Loan request electronically. I understand that:

- In order to apply for the Direct Plus Loan, the parent must apply online at https://studentloans.gov Select sign in. Once you have signed in, select Start PLUS Application.
- If the Department of Educations approves your loan (subject to a credit check), you will need to complete the PLUS Master Promissory Note (PMPN) online. You must sign and date the PMPN using your pin. I further understand that if I do not complete the PMPN in a timely manner, it will delay receipt of my Federal PLUS loans funds.
- Effective March 30, 2015 parents must complete a PLUS Counseling session provided on www.studentloans.gov before a PLUS Loan can be processed.
- Funds will be released to BankMobile for disbursement according to Wake Tech's published refund schedule. The ACTUAL date that the refund is received is based on the students designated refund preference:
 - Deposit to another account. Money in 2 to 3 business days.
 - Deposit to a BankMobile checking account. Money in 1 to 2 business days.

If your student does not activate their refund preference funds may be delayed up to two weeks. Parents may opt to have check mailed directly to you.

Additional Refund Preference: Parents can request they personally receive the PLUS funds by paper check.

- You must abide by all rules and regulations of the Federal PLUS loan program.
- The Department of Education may charge up to 3% of the loan amount requested as an origination fee; however, you are still responsible for paying back the entire amount of the loan in addition to any accrued interest. Lender repayment options are subject to change without notice.
- Your student must register for and attend at least six (6) credit hours per semester of enrollment and be
 maintaining Satisfactory Academic Progress in order to remain eligible for the PLUS loan. At the time of
 disbursement, student must be registered for six (6) credit hours and actively attending six credit hours.

If you wish to receive a Federal PLUS loan in future years, you must re-apply with a new Federal PLUS Request form.
