COSMETOLOGY PATHWAY

The Cosmetology Program is approved by the NC State Board of Cosmetic Arts. The course introduces basic "Cosmetology Skills" needed in a salon setting.

In addition to the CCP program eligibility requirements, the Cosmetology program has separate requirements and expenses that prospective students should be aware of.

The following are expenses for Cosmetology (COS111 and COS 112):

- **Identification:** Official NC ID or NC DL and SS card. No copies are accepted. Prior to first day of Class; Bring to Cosmetology Main Campus; See Paula Askew or Receptionist.
- **Permission Slip:** Parental consent is needed if under the age of 18
 - ❖ Email: Paula Askew for the parental consent form pbaskew@waketech.edu
- **Textbook and Workbook:** Textbooks are provided
- **Uniform:** (2-3) Worn on first day of class (cost varies) with Black closed toe shoes (nursing scrubs, under garments, and shoes – entire uniform, shoes, etc... must be Totally Black)
- **Monogramming on Uniform can be any color and font that shows up and can be read on Black**
 - **First and Last Name on 1st row** **Example: Paula Askew**
Cosmetology Semester and Year on 2nd Row **Cosmetology**

- **Mannequins with matching Stand:** Purchase (2) mannequins 1 per semester Fall and Spring
