### Satisfaction of Admissions Requirements

All precurriculum class work, SAT/ACT score, college placement test scores, associates' degree, bachelor's degree, and high school GPA must be **within 10 years** of the first MLT class you are applying for.

**READING / ENGLISH:** proficiency should be satisfied by completion of any **ONE** of the following:

- ☐ Completion of ENG 111 or equivalent with a minimum grade of "C"
- ☐ Completion of prerequisites to be eligible to register for ENG 111 without co-requisite
- ☐ Meet score on a placement test to be eligible to register for ENG 111 without co-requisite
- ☐ Meet NCCCS high school GPA waiver through Multiple Measures or RISE
- ☐ Provide proof of completion of an associate's degree or higher

**MATH:** proficiency should be satisfied by completion of any **ONE** of the following (*within the past 10 years*):

- ☐ Meet score on placement test to be eligible to register for MAT 143 without co-requisite
- ☐ Completion of MAT 143 or higher with a minimum grade of "C"
- ☐ Successful completion of MAT 070 or DMA 010 through DMA 050 or MAT 003, grade P2
- ☐ Meet NCCCS high school GPA waiver through Multiple Measures or RISE
- ☐ Provide proof of completion of an associate's degree or higher within the past 10 years

**CHEMISTRY:** proficiency should be satisfied by completion of any **ONE** of the following:

- ☐ High School or College Chemistry course with a minimum grade of "C"
- ☐ CHM 090 or 092 or equivalent with a minimum grade of "C"
- ☐ Successful completion of the CheMOOC final.

### NOTE:

College-level math courses and/or placement test scores, including SAT and ACT, must have been completed **within 10 YEARS** of the program application deadline.

*All official transcripts must be turned in by the MLT application deadline, to receive transfer credit! All transcripts must be original and come from the originating source. Copies of transcripts are not acceptable.*

Only the twenty-four applicants who have met the above admissions requirements **and** have been accepted into the program are allowed to register for the MLT curriculum.

**Completion of BIO 163 is worth 2 points.** Students with the most points and the earliest program application submission date will be accepted into the MLT program and permitted to register for the MLT classes.
