Estimated date instruction will resume at the original location: January 1, 2021 (158 days)

SACSCOC accepts notification for up to 60 days, renewable for an additional 60 days if needed. Relocation beyond 120 days requires approval.

Because the coronavirus outbreak presents a unique challenge to reliably estimating the date instruction will return to original locations, we are by default accepting notification for the 120-day maximum and approving relocation through December 31, 2020.

We confirm the institution is approved for distance learning. The institution may offer any portion of any current program, or any new program that is not a significant departure from existing programs, via distance learning (i.e., online).

We accept notification and the Board of Trustees of the Southern Association of Colleges and Schools Commission on Colleges approves the temporary emergency relocation of instruction from South Campus (main campus); Public Safety Education Campus; Perry Health Science Campus; Vernon Malone College and Career Academy; Scott North Wake Campus; North Wake College and Career Academy; RTP Campus; Western Wake Campus; Beltline Center; Eastern Wake Center to Distance learning, effective July 27, 2020 to December 31, 2020.
